Introduction

Sections 449-462 of the Education Act 1996 set out the law on charging for school activities, as well as confirming that schools must ensure that they inform parents on low incomes and in receipt of certain benefits of the support available to them when being asked for voluntary contributions towards the cost of school visits.

The Governing Body of Crockerton School believe that that all our pupils should have an equal opportunity to benefit from school activities and visits (curricular and extra curricular) independent of their parents' financial means.

This charging and remissions policy describes how we will do our best to ensure a good range of visits and activities is offered and, at the same time, try to minimise the financial barriers which may appear to prevent some pupils taking full advantage of the opportunities.

This policy identifies:

- Where Voluntary contributions may be requested
- When Charges will not be made
- When Charges will be made
- Where Remissions will apply
- The School Fund

The school day is defined as: from the morning starting time to the afternoon closing time, as they may be from time to time defined. The midday break does not form part of the school day.

Voluntary Contributions may be requested:

Separately from the matter of charging, schools may always seek voluntary contributions in order to offer a wide variety of experiences to pupils.

The Governing Body accepts the basic principle that any activity that takes place mainly in school hours which is beyond the normal curriculum, but deemed sufficiently important to take up school time, should be free. However, voluntary contributions will be invited to meet the full cost.

All requests for voluntary contributions will emphasise their voluntary nature and the fact that pupils of parents who do not make such contributions will be treated no differently from those who have. No child will be excluded from an activity because his or her parents are unable or unwilling to pay.

If the activity cannot be funded without voluntary contributions the Governing Body or Headteacher will make this clear to parents from the outset.

If insufficient contributions are received, the trip or activity may have to be cancelled.

Charges will not be made for:

- An admission application
- Education provided during school hours (including the supply of any materials, books, instruments or other equipment);
- Education provided outside school hours if it is part of the National Curriculum, or part of a syllabus for a prescribed public examination that the pupil is being prepared for at the school, or part of the school's basic curriculum for religious education;
- Tuition for pupils learning to play musical instruments (or singing) if the tuition is required as part of the National Curriculum, or part of a syllabus for a prescribed public examination that the pupil is being prepared for at the school, or part of religious education;
- Entry for a prescribed public examination, if the pupil has been prepared for it at the school;
- Examination re-sit(s) if the pupil is being prepared for the re-sit(s) at the school;
- Education provided on any trip that takes place during school hours
- Education provided on any trip that takes place outside school hours if it is part of the National Curriculum, or part of a syllabus for a prescribed public examination that the pupil is being prepared for at the school, or part of the school's basic curriculum for religious education;
- Supply teachers to cover for those teachers who are absent from school accompanying pupils on a residential trip;

Charges will be made for:

1. Activities outside school hours

Residential and non-residential activities (other than those listed above) which take place outside school hours, but only if the majority of the time spent on that activity takes place outside school hours (time spent on travel counts in this calculation if the travel itself occurs during school hours).

- 2. **Residential visits during school hours** The board and lodging costs (but only those costs) of residential trips deemed to take place during school time. However pupils whose parents are in receipt of certain benefits (see remissions policy below) will be exempt from paying the cost of board and lodging.
- 3. **Music tuition** Music tuition for individuals or appropriate sized groups of pupils to play a musical instrument or to sing and which is not an essential part of either the National Curriculum or a public examination syllabus for all pupils.
- 4. **Breakfast Club** Breakfast Club is offered as an extra convenience to parents arranged by an outside agency. Parents pay this company for their services directly.
- 5. **After School Club** After School Club is offered by the school for the convenience of parents wishing their child to have child care at the end on the school day. The small charge made to the parents is to cover the cost of the children's refreshments and art activities.
- 6. **Some after school clubs e.g. Knitting** A small charge may be requested from the parents of children attending these clubs to cover the cost of refreshments and materials used at the session.

Remissions: In order to remove financial barriers from pupils, the governing body has agreed that some activities and visits where charges can legally be made will be offered at no charge or a reduced charge to parents in particular circumstances. This section sets out the circumstances in which such charges will be waived.

When a parent /carer can prove they are in receipt of any of the following benefits, they will be exempt from paying the cost of board and lodging:

Income Support (IS);

- Income Based Jobseekers Allowance (IBJSA);
- Support under part VI of the Immigration and Asylum Act 1999;
- Child Tax Credit, provided that Working Tax Credit is not also received and the family's income (as assessed by Her Majesty's Revenue and Customs) does not exceed £16,190
- the quarantee element of State Pension Credit;
- Income related employment and support allowance.

School Fund

For those parents / carers who may be facing financial hardship in order to pay for an activity or trip, a small fund is available. These funds have been donated PTA of the school and are maintained and administered by the school. Please feel free to contact your child's teacher or the Headteacher if you wish to make a claim from this fund. All arrangements will be made in the strictest confidence.

Payment terms

The governing body recognises its responsibility to ensure that the offer of activities and educational visits does not place an unnecessary burden on family finances. To this end we:

- Will try to establish a system for parents / carers to pay in instalments
- Will try to ensure that if an opportunity for an activity arises at short notice it will be possible for carers / parents to arrange to pay by instalments beyond the date of the activity
